# 8. DISCUSSION OF ASSOCIATION BUSINESS AND MATTERS AT HAND:

- 8.1 B.A.S.S. NATION ALLIANCE & MEMBERSHIP CARDS DEADLINE SET:
  - Deadline was set at the 2018 AGM for the end of February 2019.
  - AH to get quotes for cards at Schoemans.
  - AH & RG to finalise the proposal and draft contract in order to meet with potential alliance partners as soon as possible.
  - Cost of cards will be carried by members as decided at the 2018 AGM.
  - Sponsors that have supported the NBAA throughout the years will be contacted.
  - All outlets will have the freedom to determine own discount structure and the NBAA will not force any outlet to a certain percentage discount.

# 8.2 HONORARY MEMBERSHIP – NBAA HALL OF FAME:

- The next NBAA Hall of Fame member will be Naas Jacobs.
- RG will contact Alec Williams to get info that he has compiled about Naas Jacobs and the Hall of Fame will be updated accordingly.

# 9. SELECTION CRITERIA FOR CIPS/ FIPSed BLACK BASS WORLD CUP TEAM:

- The selection criteria was set at the 2017 AGM it was voted in that the World Championships team could contain 1 foreign national. At the time members where under the impression that the team members who are Namibian would still obtain national colours and only the non-national team member would not obtain national colours.
- The NFFA confirmed with the NSC they will not issue national colours to a team containing 1 foreign national and should a foreign national qualify the entire team will compete as a non-national team. This confirmation was received after the 2017 AGM.
- CIPS/ FIPSed allows for non-national team to compete.
- Question to be posed to members: Yes / No MUST the team competing at the Black Bass World Championship be a national team?
- The chair will ask members present at the SGM if the matter above can be added to the agenda.
- EXCO has discussed and voted on the matter and a recommendation will be made to members should the point be allowed.

# 10. WEIGH STATION:

- Discussions pertaining to the building of a permanent weigh station at both Oanob & Von Bach Dam has been underway with both parties through the course of 2018.
  - Tungeni cannot approve as the location where the weigh station has been planned is owned by NWR.
  - NWR will be contacted to put forward the plan on the weigh station and approval will be sought.
  - HP will research who the contact person is and will start with discussions for permission.
  - Lake Oanob Resort has been willing to discuss the matter further. The biggest concern for Lake Oanob is the high water mark. The weigh station might have to be built on stilts.
  - HP to contact Mr Wilbur Slabber as soon as possible to resume with the envisaged project.
  - RG thanked Mr Thinus Williams for the architectural renderings (below) for the envisaged permanent weigh stations.

- According to our constitution, all anglers that will be participating in the World Championships must be in good standing with the NBAA. RG asked NvT to double check if all nominated anglers are indeed in good standing. If there are members not in good standing then the debt MUST be settled before the team departs for the World Games in February.
- Region V team to be nominated next. Deadline for nomination is set for the 25<sup>th</sup> of February 2019. Once again, as per NBAA rules, only members in good standing can be nominated. Members who are not in good standing who are eligible for nomination must be contacted before the
- Additional information to be obtained from SA (host country for 2019) before the President's team is nominated, NvT to co-ordinate.
- The NBAA could be in a position not to be able to nominate a presidents team for 2019 due **NvT** to the 2018 qualifying criteria.
- **NvT** The selection committee was asked to report back to EXCO with the current presidents' team nominations for 2019 in order to determine the feasibility of having a team at all for 2019.

#### 12. PRIZE GIVING EVENT 2019:

  the World Champs team will not have the opportunity to practice for the 1<sup>st</sup> tournament of

# 17. 2019 REGION V TOURNAMENT:

- Mr Carl Hack from Zimbabwe has already established a Whatsapp group for the 2019 tournament. Once the team has been selected the team captain and team manager will be added to the group.
- The 2019 tournament will be hosted by Zambia and the likelihood of it being at Lake Chicamba is 99%.
- The team will have to organise their own tournaments, the team captain and manager to make all arrangements regarding the team, payments, logistics, clothing, travelling, accommodation, etc.
- RG will be able to assist the team captain and manager with contact details of people / companies required to put together a Region V tour as well as procedures and protocols to be followed.

# 18. 2020 REGION V TOURNAMENT:

- Namibia was next in line to host as per the rotation system in place.
- A decision was made at the last Region V AGM that the rotation system for hosting be abolished and replaced with a tender system. Countries that want to host will tender based on good fishing as well as costs. The country that wins the tender will host. The biggest reason for the implementation of the system was the cost of the 2018 event.
- Namibia submitting a tender for the 2020 tournament will by determined on the amount of inflow both our bass angling impoundments receive in the first months of 2019.
- EXCO will have to make this decision at the end of May 2019.
- Should the decision be favourable the tender will be submitted at the 2019 Region V AGM to be held in June / July.
- RG mentioned how dear hosting the Region V tournament is to him and how much it would mean to the sport of bass angling in Namibia.
- RG asked EXCO to do everything in its power to ensure that the tender is submitted.

 RG also committed to continue planning talks will all stakeholders as if the 2020 Region V was going to be hosted in Namibia.

# 19. NBAA MERCHANDISE STORE:
