#### 21.3 Score Fishing:

- AH to elaborate EXCO to discuss.
- Score Fishing is a company in the UK that has an online weigh in scoring system.
- This system can be use offline as well which means if there is poor internet access the system can still be used.
- The scoring system works differently in the way we are currently calculating the scores however they are able to assist to develop the program for our comfort.
- A demo / test run on the system can also be done to see if it is something the NBAA can use to make the scoring faster and to see the standings immediately.
- This will help us to hand out the medals immediately after the weigh in is done after each tournament.
- The costing is 500.00 pounds per year.
- AH will contract them for more information regarding the test run.

#### 21.4 Keepnet.com:

- JC to elaborate EXCO to discuss.
- Keepnet.com is used by Zimbabwe and they have had a lot of success during tournaments.
- The system is an online system and it can also be used offline and anglers can login and have assess to the score sheets.
- The logistics regarding the login of all anglers needs to be determined and more information needs to be obtained to see if it will be beneficial to the NBAA.
- The system also needs to be tested to determine if the NBAA can use it or if development needs to be done.
- JC will contact them to determine if the program can be modified to suite the NBAA.
- More information will be gathered regarding the above apps and see which one will be more beneficial to the NBAA.
- The costing involved to develop a new app just for the NBAA will also be looked at and will be discussed at the next EXCO meeting.
- A suggestion was also put forward to use the current method NALAA is using to take a
  video of all fish caught and using a measuring mat to determine the weigh and the length of
  the fish.
- Taking a video of the catch will become difficult once an angler is alone on the boat.
- Conservation of the fish is being kept in mind with regards to the app and more information will be put together and discussed at the next EXCO meeting.

# 21.5 Treasurer Vacancy:

- The vacancy was discussed, and RG asked JC if he would mind taking over the portfolio of treasurer as he is a qualified accountant. JC agreed.
- RG has spoken to Mr Pierre Fourie to take over the conservation officer portfolio. Mr Fourie agreed and will be invited to the next EXCO meeting.

# 21.6. **Breeding Bass:**

- EXCO met with Mr Wilhelm Steenkamp who is on the process of building a hydroponic facility to grow vegetables. Mr Steenkamp will be breeding / keeping freshwater fish in the facility and has offered to try breeding bass.
- Various studies will be conducted to determine if this option will be a feasible one for the NBAA.
